**Media Synopsis:**

On January 10, 2014, Harris, then 25, of Cleveland, caused the death of his girlfriend's two-year-old son. The child's mother left the child in Harris' care while she took a shower. When she returned the child was limp and not breathing. The Cuyahoga County Medical Examiner's Office ruled the death a homicide and said the child died from internal injuries caused by blunt force trauma.

Harris was found guilty on July 7, 2016, of Murder, Felonious Assault, Involuntary Manslaughter, Endangering Children, and Domestic Violence.

Sentencing is scheduled at 11:00 a.m.

**Media Synopsis:**

On February 11, 2015, Jessica Ebsch, 26, left her 8-month old child in the care of her brother and his girlfriend, and her cousin Raymond Benes, 28, who had been drinking and smoking marijuana throughout the evening.

Benes later brought the crying baby to bed, then fell asleep on top of the child, suffocating her. On July 6, the defendants plead guilty to Reckless Homicide and Endangering Children.

Sentencing is scheduled for 10:00 a.m. on 8/11/2016.
