<p>Media Synopsis:</p> <p>Defendant had a verbal altercation with her boyfriend, victim Stacey Moore, 27, in the early morning hours of May 7, 2016. Defendant then took off in her 2014 Chevrolet Impala down East 25th Street with Moore hanging onto the outside of the vehicle. Lawson drove over a curb, struck a park bench, a steel guardrail and a chain-link fence. The car went airborne and landed on the I-90 WB exit ramp to Chester Avenue, then crashed into a vehicle traveling on the exit ramp. Media Synopsis:

Defendant Lykins began chatting with a 13 year old juvenile from Norton on an Application called Whisper and when he found out her age he continued his pursuit. He asked the girl to engage in fellatio, sexual activity, and even asked for nude pictures of her, while also sending her pictures of his genitalia. ICAC investigators received the referral and executed a search warrant at Defendant's business. ICAC found all the evidence of the conversations between Defendant and the 13 year old. They also found a phone belonging to Defendant containing over 100 images of child pornography saved to his phone. On September 8, 2016, Defendant pleaded guilty to 20 counts of Illegal Use of a Minor in Nudity Oriented Material or Performance, felonies of the second degree; 29 counts of Pandering Sexually Oriented Matter Involving a Minor, felonies of the second degree; 16 counts of Disseminating Matter Harmful to Juveniles, felonies of the fifth degree, one count of Importuning, a felony of the fifth degree, and one count of Possessing Criminal tools, a felony of the fifth degree.

Sentencing is scheduled to begin at 11:00am.
