<b>Media Synopsis:</b> <p>On November 28, 2015, Logan Sinclair, 21, of Cleveland entered the Sunoco gas station at 5385 Pearl Road and pointed a handgun at the business owner Robert Sposit and demanded money from the cash register. Sinclair removed money from the cash register and attempted to flee the store after committing the aggravated robbery.</p> <p>Sposit shot at Sinclair and Sinclair fell to the ground. Sposit then attempted to detain Sinclair by standing over him and holding him at gunpoint. **Media Synopsis:**

On August 25, 2015, the 24-year-old defendant was driving her 1997 Dodge Ram pickup recklessly on I-71 South near Denison Avenue when she lost control. Both the driver and her passenger, Aaron J. Maxwell, 20, were ejected from the vehicle. Maxwell died a short time later at MetroHealth Medical Center.

On September 26, defendant pled guilty to Aggravated Vehicular Homicide and Felonious Assault

**Media Synopsis:**

The defendants planned the retaliation murder of victim Robert Williams, 63. The defendants shot and killed Williams in the hallway of his Indian Hills apartment building on December 9, 2015.

On October 3, Raymond Motley, age 24, pled guilty to Involuntary Manslaughter, Conspiracy, and Aggravated Burglary

On October 3, Young, age 35, pled guilty to Involuntary Manslaughter and Conspiracy

On October 5, Ryan Motley, age 21, pled guilty to Murder and Conspiracy

Sentencing is scheduled to begin at 1:00 p.m.

After an eight-day trial, defendant Brownlee, 48, was found guilty of Murder, Aggravated Murder, Conspiracy, Felonious Assault, Aggravated Burglary, and Kidnapping. He was sentenced on October 19 to life in prison plus 33 years.
