George, Anika | Boynton, Andre D.

Media Synopsis:

George, then 35, of North Royalton, traveled to Cleveland and enticed four young boys (ages 9-13) with cash and video games. On multiple occasions from June 30 – July 27, 2014, George brought the boys to her apartment and engaged in sexual conduct with them. She also directed the victims to engage in sexual activity with a female minor, 14, who is developmentally disabled.

George filmed all the illicit encounters on a cellphone under the direction of Boynton, her boyfriend, who is serving time in prison. He has been charged as co-conspirator.

The 150 count indictment also includes charges of Voyeurism for photos of elderly patients in varying stages of undress, taken by George at a nursing home where she worked.

Trial is scheduled to begin at 9:00 a.m. on April 3, 2017.

On January 21, 2016, at Lee Rd and Miles Avenue, the defendants punched and knocked the victim to the ground then repeatedly kicked and stomped on the victim's head. The victim died as a result of blunt force trauma.

On December 19, 2016, defendants Gunn and Hilton pled guilty to Attempted Involuntary Manslaughter.

On January 11, 2017, the Ohio ICAC Task Force initiated an investigation based on the content of an online classified advertisement. The defendant made plans to meet the girl at a pre-arranged location when he was taken into custody.

On March 8, defendant pled guilty to Importuning and Compelling Prostitution.
