

Al Dhannoon, a person other than the accomplice, was present, with purpose to commit in the structure or in the separately secured or separately occupied portion of the structure a criminal offense, to wit: Violating Protection Order, 2919.27, and the offender recklessly inflicted, or attempted or threatened to inflict physical harm on Roaa S. Al Dhannoon.

*The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.*







**Count Thirteen**   **Telecommunications Fraud - F5**




**Count Fifteen**    **Possessing Criminal Tools - F5**

**Date of Offense**    On or about October 16, 2016 to October 20, 2016


*The grand jurors, on their oaths, further find that the Defendant(s) unlawfully*
