Media Synopsis: On July 16, 2014, in the parking lot of the Marathon gas station located at 2625 East 55th Street, during a heated argument with the victim's friend, Sanderson, 23, of Cleveland, attempted to hit the victim with her vehicle. The victim jumped onto the hood of Sanderson' vehicle. Sanderson sped out of the parking lot, with the victim still on her hood, into traffic. Sanderson crossed the center line and struck an oncoming vehicle. The victim was thrown from the hood and into the path of another car. The victim was transported to MetroHealth Medical Center and was pronounced dead on arrival. Media Synopsis:

Copeland, 33 of Maple Heights and Leverett, 32 of Bedford Heights were involved in an argument with the victim who worked at LeeJay's Beverage Store in Cleveland. Copeland and Leverett beat the victim and stabbed him to death.

On December 22, 2014, Leverett entered a plea of guilty to one count of Attempted Felonious Assault. On that same day, Copeland entered a plea of guilty to one count each of Involuntary Manslaughter and Kidnapping. Sentencing is scheduled to begin at 9:00 a.m.
