### Media Synopsis:

On May 8, 2014, members of the Environmental Crimes Task Force and other agencies executed a search warrant at 6401 Grand Avenue after receiving complaints referencing the presence of scrap tires, rodents and illegal dumping. Results of the search warrant revealed solid waste including scrap tires and other debris, stolen vehicles, potential air quality violations, as well as 2 malnourished dogs and 2 malnourished horses. The illegal facility was operated by AC Cooper, 64, Joe Cooper, 64, and Patricia Cooper, 60, all of Cleveland.
