Media Synopsis: On August 19, 2014, Wright, now 40, of Cleveland offered two teen girls a ride in his car. He then bought alcohol and shared it with them. He then put a gun the 14-year-old's head and forced her to perform oral sex. He repeatedly refused to let them out and told the 15-year-old she was next. When he finally stopped the car, he went into a business and hid the gun in a stack of newspapers. He had given the girls \$20 to keep quiet. On January 7, 2015, Wright entered a plea of guilty to one count of Sexual Battery with a firearms specification and one count of Receiving a Stolen Firearm. Sentencing is scheduled to begin at 9:00 a.m.

Media Synopsis:

Walker, 23, of Garfield Heights, Thomascik, 26, of Lakewood and Mihna, 42, of Lakewood supplied heroin to the victim who in turn overdosed and was admitted to the intensive care unit of Lakewood Hospital and died there. This case is a Re-Indictment of 584885-14-CR.

On November 25, 2014, Mihna entered a plea of guilty to one each count of Involuntary Manslaughter and Drug Possession.

He is scheduled to be sentenced on February 11, 2015 at 9:00 a.m.

On December 1, 2013, Thomascik entered a plea of guilty to one count of Permitting Drug Abuse.

She is scheduled to be sentenced on February 10, 2015 at 9:00 a.m.

On January 26, 2015 Walker entered a plea of guilty to one count each of Involuntary Manslaughter and Attempted Corrupting Another With Drugs.

He is scheduled to be sentenced on February 26, 2015 at 9:30 a.m.
