**Media Synopsis:**

Anderson, 23, Carrington, 44, and Torres, 19, all of Cleveland, forced the male victim into a van and drove him to West 47th Street where he was then forced into a garage. Anderson hit the victim over the head with a baseball bat, Torres hit him with the baseball bat, and Carrington shot and hit the victim in the face with a BB gun. The defendants also sexually assaulted the victim.

**Media Synopsis:**

William Waters, 38, of Westlake, is accused of raping seven juvenile females between 1999 and 2014.

After one of victims reported the sexual assaults to the Westlake Police Department in June of 2014, William Waters fled to Sallisaw, Oklahoma. Cheryl Waters, 62, of Westlake, aided him in his flight from law enforcement and was charged with Endangering Children and Obstructing Justice.

William Waters was apprehended in October of 2014 in Fort Smith Arkansas by the US Marshalls with numerous electronic devices and items of child pornography in his possession.

Heather Waters, 32, of Westlake, was charged with Endangering Children.
