### Media Synopsis:

On January, 23, 2015, the four-year-old victim suffered severe blunt force trauma to the head causing severe brain damage and requiring multiple surgeries. This incident occurred while the victim's father, Reece, 32, of Cleveland, was away at work. He allowed his girlfriend, Anderson, 29, of Cleveland, to baby sit despite earlier agreements to not allow her time alone with the child. Anderson claims the infant slept and fell in the bathtub.

Trial is scheduled to begin at 9:00 a.m.

### Media Synopsis:

On June 22, 2015, Alicea, 37, of Cleveland, walked behind the 87-year-old victim and grabbed the purse off her shoulder, knocking her to the ground in the process. Alicea then jumped into a minivan and sped off. The victim suffered a broken elbow that required surgery. Alicea was charged and eventually plead to one count of Aggravated Robbery for this offense in case 597140.

On June 28, 2015, Alicea robbed a patron of the Old Angle bar located on W. 25th Street in Ohio City of her purse and fled, but was chased and caught by good Samaritans. On September 10, 2015, Alicea entered a plea of guilty to one count of Robbery.

**Media Synopsis:**

The Cutthroats, a gang based out Cleveland's 5th District, were the center of a four month investigation by the Cleveland Police Gang Impact Unit. Each of the 11 defendants are charged with Participating in a Criminal Gang, Engaging in a Pattern of Corrupt Activity, and 2 counts of Conspiracy. Other charges in the indictment include Attempted Murder, Felonious Assault, Drug Trafficking, Robbery, Bribery, and a sundry of weapons charges and specifications.

On an earlier date, Allen, Taylor, Myrieckes, Hunter and Willis all entered pleas of guilty to various charges and have been sentenced.

Brooks, Townsend, Pruitt, James and Goins all entered various pleas of guilty to numerous charges, including Participating In A Criminal Gang, and are scheduled to be sentenced at 10:30 a.m.

**Media Synopsis:**

On March 22, 2015, Anderson, 23, Carrington, 44, and Torres, 19, all of Cleveland, forced the male victim into a van and drove him to West 47th Street where he was then forced into a garage. Anderson hit the victim over the head with a baseball bat, Torres hit him with the baseball bat, and Carrington shot and hit the victim in the face with a BB gun. The defendants also sexually assaulted the victim using a metal pole.

On September 14, 2015, Anderson entered a plea of guilty to one count of Kidnapping, two counts of Felonious Assault, one count of Intimidation of Crime Victim of Witness, and one count of Tampering with Evidence. Carrington entered a plea of guilty to one count each of Kidnapping, Felonious Assault, Tampering With Evidence and Intimidation of Crime Victim of Witness. Torres entered a plea of one count each of Attempted Felonious Assault, Tampering With Evidence and Intimidation of Crime Victim of Witness.
