<b>Media Synopsis:</b> On March 8, 2015, at the Parmatown Chuck E. Cheese, a melee ensued, resulting in several workers sustaining physical injuries.  On July 20, 2015, Watts, 21, of Cleveland, entered a plea of guilty to one count of Attempted Aggravated Riot; Green Jr., now 23, of Cleveland, entered a plea of guilty to one count of Assault and Green Sr., 44, of Parma, entered a plea of guilty to one count of Aggravated Riot. All were sentenced at an earlier date and received fines ranging from \$25-\$100. **Media Synopsis:**

On June 3, 2015, Dejesus, now 27, of Cleveland, entered the victim's vehicle while he was stopped at a red light. Dejesus began assaulting the victim and ultimately caused him to crash his vehicle near Detroit Avenue and West Boulevard. The victim was transported to MetroHealth where he was pronounced dead as a result of his injuries.

Dejesus pled not guilty by reason of insanity and waived his right to a jury trial. The bench trial is scheduled to begin at 9:00 a.m.
