Media Synopsis:

On January, 23, 2015, the four-year-old victim suffered severe blunt force trauma to the head causing severe brain damage and requiring multiple surgeries. This incident occurred while the victim's father, Reece, then 32, of Cleveland, was away at work. He allowed his girlfriend, Anderson, then 29, of Cleveland, to baby sit despite earlier agreements to not allow her time alone with the child. Anderson claims the infant slipped and fell in the bathtub.

An initial investigation of an IP address involving child pornography was found to be registered with Eccles, 43, of North Olmsted, as the subscriber. A search warrant was executed by the Ohio Internet Crimes Against Children Task Force on July 17, 2015. Evidence seized found Eccles to be in possession of tens of thousands of files containing child pornography.

On August 21, 2015, Lennon, then 19, exited an automobile brandishing a handgun and fired numerous rounds towards a group of people that included members of the Buckeye Boys street gang, near East 117th Street and Buckeye Road. Two individuals were wounded, including a 13-year passerby who was hit in the hand. A bank building and a car park nearby were damaged by the shots.
