Media Synopsis:

On April 15, 2015, the 10-year-old victim was with Hurth, his father, playing video games. Hurth was drinking. When the victim wanted to quit during a game, they began to argue and Hurth grabbed the victim by the shirt collar and ordered him to leave the house.

While the child was calling his mother, Hurth grabbed the phone, ended the call and then shoved the victim into the wall and put his hands around his neck and threw him onto the bed. He then punched him in the back and hit him in the head with an open hand.

Hurth, 47, of Cleveland, has five prior DV convictions. On February 8, 2016, Hurth entered a plea of guilty to one felony count of Domestic Violence.

Sentencing is scheduled to begin at 9:00 a.m.

Lennon, Dominique

Media Synopsis:

On August 21, 2015, Lennon, then 19, exited an automobile brandishing a handgun and fired numerous rounds towards a group of people that included members of the Buckeye Boys street gang, near East 117th Street and Buckeye Road. Two individuals were wounded, including a 13-year-old passerby who was shot in the hand. A bank building and a car parked nearby were damaged by the shots.

Media Synopsis:

On October 20, 2015, Rauscher robbed a bank on Cleveland's west side. Rauscher passed a teller a note indicating that he wanted money and had a gun, and that no one would get hurt if the teller handed over the money.

On January 25, 2016, Rauscher, 24, of Cleveland, entered a plea of guilty to one count of Aggravated Robbery.

Harris, Michael

Media Synopsis:

On January 10, 2014, Harris, then 25, of Cleveland, caused the death of his girlfriend's two-year-old son. The child's mother left the child in Harris' care while she went into the bathroom to shower. When she returned the child was limp and not breathing. The Cuyahoga County Medical Examiner's Office ruled the death a homicide and said the child died from internal injuries caused by blunt force trauma.
