Media Synopsis: Young, now 49, of Cleveland, was the first "John Doe" indicted in cold case rapes presented to the Grand Jury as part of the Cuyahoga County Sexual Assault Kit Task Force initiative. In 2013, Young was sentenced to 32 years in prison in case 566461, and DNA connected during intake linked him to the 1993 rape of a 13-year-old victim and the 1996 rape of a 34-year-old victim. Media Synopsis:

Laster, Barnes, Bush and Dent are each facing a charge of Participating in the Criminal Gang for belonging to the Detroit Taking Over or DTO gang. The gang was indicted with several incidents related to automobiles stolen on the West Side of Cleveland and the surrounding suburbs during the summer and fall of 2015. The indictment covers incidents of aggravated robbery (Laster), burglary (Bush and Barnes), and being in possession of stolen vehicles (Laster, Barnes, Bush, and Dent).

Trial is scheduled to begin at 9:00 a.m.
