Media Synopsis:

On October 18, 2016, the 23-year-old defendant and his girlfriend were arguing outside of the Phantasy Night Club on Detroit Ave. in Lakewood. Several people broke up the argument after it turned physical. The defendant fled, then shortly returned to pick up his girlfriend.

As he left the second time, he fired several rounds from a 9mm handgun into the crowd in front of the club, striking two.

On May 1, a Cuyahoga County jury found him guilty of Attempted Murder, Felonious Assault, Discharge of a Firearm on or Near Prohibited Premises, Improperly Handling Firearms in a Motor Vehicle, Criminal Damaging, Domestic Violence, and Having Weapons Under Disability.

Sentencing is scheduled to begin at 9:00 a.m.

Media Synopsis:

The 21-year-old defendant will be tried on capital murder charges in the shooting deaths of five people on Friday, November 21, 2014, at a residence on East 92^{nd} Street.

Victims Lemon Bryant, 60, Shaylona Williams, 17, and Ja'rio Taylor, 18, were inside the home. Each had suffered multiple gunshot wounds.

Sherita Johnson, 41, was shot and killed in the driveway. She was 28-weeks pregnant but the baby died shortly after being delivered at the hospital. Johnson's 9-year-old daughter was also shot but survived.

Trial is scheduled to begin 9:00 a.m.
