In 2016, the 20-year-old defendant raped and beat a 65-year-old female victim in June, and then in December he raped and beat an 18-year-old female victim who was five-months pregnant.

On May 8, 2017, the defendant pled guilty to nine charges including Rape, Aggravated Robbery, Kidnapping, and Felonious Assault.

Sentencing is scheduled to begin at 9:00 a.m.

Media Synopsis:

On August 10, 2016, defendant Hill, 41, made arrangements to meet the four victims at an address of an abandoned home on Tarkington Road in Cleveland to complete a drug transaction. The victims were led to believe it was an occupied residence.

Bulger, 26, showed up and demanded money and drugs from the victims. The driver of the vehicle, 26-year-old Stephen Menter, tried to drive away and was shot two times, resulting in his death.

On May 5, a jury found Hill guilty of Involuntary Manslaughter.

Sentencing is scheduled to begin at 1:15 p.m. on June 6.

Trial for Bulger, 26, is scheduled to begin on June 19.

Media Synopsis:

On December 12, 2015, the victim Richard Brichacek, 63, was found deceased in his bed with untreated bed sores and severe malnutrition. He suffered from Charcot Marie Tooth Syndrome, a form of muscular atrophy, and was bedridden. The defendants were his sole caretakers.

On May 8, Deborah Brichacek, the victim's wife, pled guilty to Involuntary Manslaughter and failing to Provide for Functionally Impaired Person.

Wendi and Debbi, the victim's daughters, pled guilty to Failing to Provide for Functionally Impaired Person.

Brian, the victim's his son, pled guilty to Attempted Felonious Assault.

All four defendants are scheduled to be sentenced at 9:00 a.m.
