George, Anika | Boynton, Andre

George, then 35, of North Royalton, traveled to Cleveland and enticed four young boys (ages 9-13) with cash and video games. On multiple occasions from June 30 – July 27, 2014, George brought the boys to her apartment and engaged in sexual conduct with them. She also directed the victims to engage in sexual activity with a female minor, 14, who is developmentally disabled.

George filmed all the illicit encounters on a cellphone under the direction of Boynton, her boyfriend, who is serving time in prison. He has been charged as co-conspirator.

The 150-count indictment also includes charges of Voyeurism for photos of elderly patients in varying stages of undress, taken by George at a nursing home where she worked.

Trial is scheduled to begin at 9:00 a.m.

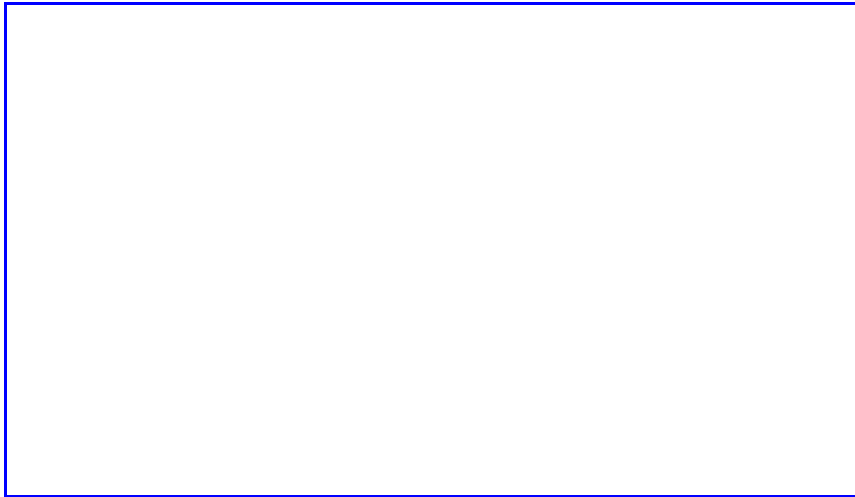
Media Synopsis:
