**Media Synopsis:**

On August 10, 2016, defendant Hill, 41, made arrangements to meet the four victims at an address of an abandoned home on Tarkington Road to complete a drug transaction. The victims were led to believe the home as an occupied residence.

Bulger, 26, showed up and demanded money and drugs from the victims. The driver of the vehicle, 26-year-old Stephen Menter, tried to drive away and was shot two times, resulting in his death.

On May 5, a jury found Hill guilty of Involuntary Manslaughter. He received a sentence of 11 years in prison.

Trial for Bulger is scheduled to begin at 9:30 a.m.

In 2016, the 65-year-old male victim's body was discovered under a Cleveland bridge. Kennedy, then 29, was in a long-term relationship with the defendant. He plotted the murdered with the help of Wood, then 23, and they hid the body on the premises of the victim's North Olmsted home.

After two months, they enlisted the help of DeLeon to dispose of the body.

Kennedy pled to Aggravated Murder, Aggravated Burglary, Murder, Felonious Assault, Theft, Tampering with Evidence, and Abuse of a Corpse. He received a sentence of life in prison and will not be eligible for parole for 30 years.

Wood pled to Involuntary Manslaughter, Aggravated Burglary, Felonious Assault, Theft, Tampering with Evidence, and Abuse of a Corpse. He received a 23 year prison sentence.

Defendant DeLeon, 24, pled to Tampering with Evidence and Abuse of a Corpse.

His sentencing is scheduled to begin at 10:30 a.m.
