<p>Media Synopsis:</p> <p>On March 25, 2017, the defendants were in a vehicle traveling west on Woodland Avenue near E. 89th Street when they opened fire at a Saturn that was occupied by four males. Two individuals died as a result of the gunfire. A 15-year-old male passenger in the Saturn died of a gunshot wound to the head; a second male victim, 61-year-old David Wilder, was struck by a stray bullet as he traveled west on Woodland.</p> <p>On October 11, defendant Williams, 19, pled to Aggravated Murder and Felonious Assault. Defendant 56-year-old Coleman, AKA Willie Coleman Ali-El, is a member of a group of sovereign citizens who call themselves Moors. The defendant had a business disagreement with three victims and claimed they owed him money. He sent threatening letters stating he will take their property if they did not comply with his demands.

Coleman then filed fraudulent UCC Financing Statements with the Ohio Secretary of State, the Cuyahoga County Fiscal Officer, and the Summit County Fiscal Officer on property owned by the victims worth nearly \$11.5 million dollars.

Trial is scheduled to begin at 8:00 a.m.

On February 23, 2017, the 49 year-old East Cleveland Police Officer engaged in an illegal traffic stop of two females. During the stop, Bolton sexually assaulted both women with a sex toy. Afterward, Bolton wrote his personal cell phone on a piece of paper and handed it to one of the women.

On September 11, defendant pled to Gross Sexual Imposition and Interfering with Civil Rights.
