#### Media Synopsis:

In 2009, the defendant began sexually assaulting his adopted daughter, who was only 10-years-old at the time. This abuse went on for several years. The defendant, 58, would beat her with an extension cord if she resisted him. She has scars from the abuse. He also sexually assaulted his biological daughter approximately 14 years ago.

On January 16, the defendant pled to 17 charges including Rape, Endangering Children, Importuning, Sexual Battery, and Domestic Violence. He faces up to 130 years in prison.

Sentencing is scheduled to begin at 9:00 a.m.

## Dukes, Robert | Teal, Antonio

#### Media Synopsis:

On March 23, 2017, defendants Dukes, 24, and Teal, 30, went to Beachwood Mall to sell a large amount of marijuana. In an attempted robbery by the unknown buyers, Teal was shot. He returned fire. The drugs and gun were recovered and the buyers are still at large. Teal has been confined to a wheelchair since the incident.

On January 10, Teal pled to Permitting Drug Use and Improperly Handling Firearms in a Motor Vehicle. Dukes pled to Trafficking.

Sentencing is scheduled to begin at 9:30 a.m.

#### Media Synopsis:

Between May 8 and June 23, 2017, the defendant, then 19, shot and killed two domestic cats with a rifle and then stole the deceased cats; he also shot and killed a doe. The defendant shot at and struck a car traveling on I-480, and shot out the back window of a parked car. A .22 caliber Mossberg Rifle was recovered. He also broke a window at the Brooklyn Historical Society and pulled out a mannequin, and then abandoned the mannequin nearby.

On January 24, the defendant pled to Discharge of a Firearm On or Near Prohibited Premises, Felonious Assault, Criminal Damaging or Endangering, and Cruelty to Animals.

Sentencing is scheduled to begin at 8:30 a.m.
