<p>This sister-brother duo committed 16 aggravated robberies across Cuyahoga and Summit County from April 29 through June 28, 2017. Hill went into the stores on all 16 occasions with a hooded sweatshirt and bandana covering his face. He brandished a .22 and demand money from the register. Ragland, 45, dropped off and/or picked up Hill, 43, for at least 6 of the incidents.</p> <p>On November 8, Ragland pled to six counts of Robbery, one count of Possessing Criminal Tools, and one count of Drug Possession.</p> <p>On January 30, Hill pled to 27 counts of Aggravated Robbery, 16 counts of Carrying a Concealed Weapon, and one count of Possessing Criminal Tools.</p> <p>Sentencing is scheduled to begin at 9:00 a.m.</p>

**Media Synopsis:**

On July 24, 2017, the 19-year-old defendant walked into the Dollar General on Miles Road with two males. The defendant brandished a firearm and demanded money from the register. When the 30-year-old store employee refused, stating he did not believe the firearm was real, the defendant shot him in the chest.

When the defendant fired the weapon, he struck two of his fingers and sought medical attention at Metro where he was subsequently arrested. The victim survived.

On February 8, the defendant pled to Attempted Murder, Aggravated Robbery, Felonious Assault, and Kidnapping
